## General & NRI Category PG Admissions (Dental):

- 1. All eligible candidates (whose details have been uploaded in the website of MCC of DGHS, Govt. of India, after mop-up round on 24.11.2022) are invited to "Register online "with this website **up to 6.00pm on 29.11.2022 (Tuesday)**
- 2. The inter-se-merit of the 'registered candidates' will be published with college website after 10.00 a.m. on 30.11.2022 (Wednesday) followed by e-mail to the candidates. The candidates are informed to go through the important instructions for candidates for admission to M.D.S. course ( hosted on this website) and keep ready the required certificates (in original) and other requirements specified therein.

3. The tentative schedule for counseling and admission is as follows

Note:

- 1. Candidates should report punctually at the time and date indicated in the mail, at the venue for counseling (i.e., Council Hall, Dr. D. Y. Patil Dental College & Hospital, Pimpri, Pune -411018), without fail.
- 2. No request will be entertained for change of date and time of counseling. The candidate who do not turn-up for counseling at the prescribed time and date, will forfeit their candidature for counseling/admission.

- Only those candidates who fulfill all the prescribed eligibility criteria prescribed by the MCC/MCI will be considered for admission on inter-se merit basis and in the order of NEET All-India-Rank. Mere "Online Registration" of candidates from Dr. D. Y.Patil Dental College & Hospital, Pimpri, Pune shall not entitle for counseling or admission.
- 4. If any candidate fails either to produce the required certificates (in original) or fails to make payment of the specified tuition fee and other fees, he/she will not be considered for counseling and admission.
- 5. In case non availability of NRI candidates, NRI seats will be converted to management seats category for allotment as per the merit.

- iii. Aadhaar Card (which will be returned after verification)
- iv. BDS Degree Certificate/Provisional Certificate.
- v. BDS Internship Certificate.
- vi. Permanent Dental Council Registration Certificate issued by MCI/MCC or any State Dental Council.
- vii. BDS Mark Statements (First Year to Final Year).
- viii. BDS Consolidated Statement of marks.
- ix. BDS Attempt Certificate (First year to Final year).
- x. BDS Conduct Certificate issued by the Head of Institution Last Studied.
- xi. Six Passport size & Two Stamp size colour photographs (same as in NEET admit card) and one Passport size photograph of the candidate's Father and if Mother an applicable.

- xii. Any one of the identification proofs (ID Proof as mentioned in the information Bulletin published by the National Board of Examinations. i.e., (PAN Card/ Driving License/ Voter ID/ Passport).
- xiii. Passport with student VISA, PIO card or OCI card for NRI students only.
- xiv. BDS Transfer Certificate.
  - Candidates without original certificates / documents, shall <u>not</u> be allowed to participate in the counseling.
  - Candidates who have deposited their original documents with any other institute/college/University and come for admission with a certificate stating that "their original certificates are deposited with institute/college/University" shall <u>not</u> be allowed to participate in the counseling

## Eligibility Criteria for Admission under NRI Sponsored Category

The candidates must fulfill all the eligibility criteria prescribed by the MCI/MCC for admission to MDS course respectively. Allotment for admission is subject to fulfillment of all the eligibility criteria and medical fitness of the candidates.

All the Candidates are hereby informed that those who are claiming to be NRI as per the Directions laid down by Hon'ble Supreme Court of India in (W.P. (C) No. 689/2017-Consortium of Deemed Universities in Karnataka (CODEUNIK) & Anr. Vs. Union of India & Ors) Dated 22/08/2017. Such candidates should send their relevant documents mentioned below in claim of change of category (Indian/others to NRI).

- 1. Affidavit of the person who is NRI and the sponsorer.
- 2. Documents claiming that the sponsorer is an NRI (Passport, Visa of the sponsorer)

 Relationship of NRI with the candidate as per the court orders of The Hon'ble Supreme Court of India in case (W.P. (C) No. 689/2017 – Consortium of Deemed Universities in Karnataka (CODEUNIK) & Ans. Vs. Union of India & Ors.) Dated 22/08/2017.

Relationship of NRI with the candidate should comply with the following conditions:

- a) He should be the nearest relation
- b) Definition of the nearest relation, the following relative having blood relations.
  - i) Real brother and sister of father i.e. real uncle and real aunt.
  - ii) Real brother and sister of mother i.e. real maternal uncle and maternal aunt.
  - iii) Father and mother of mother i.e. maternal grand father and maternal grand mother.
  - iv) Father and mother of mother i.e. maternal grand father and maternal grand mother.
  - v) First degree-paternal and maternal cousins.
  - vi) Such person should be NRI.
- c) Such persons should ordinarily be residing abroad.
- d) Such person should have looked after such student as the guardian of the student and evidence to that effect must have been produced before the committee by such person.
- e) There should be affidavit with aforesaid fact.
- 4. Affidavit from the sponsorer that he/she will sponsor the entire course fee of the candidate.
- 5. Embassy Certificate of the Sponsorer.
